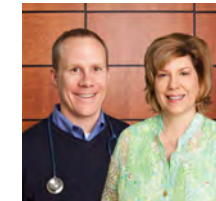

Diagnosed with advanced prostate cancer (stage four) in 2008, Bob Smith of Morton has undergone seven different treatments to fight the disease—including participating in two clinical trials at Illinois CancerCare that helped enable new treatments to go straight to commercial use for other patients.

Unfortunately, none of these treatments was able to eradicate Bob’s cancer. Still, he’s thankful for the generosity of the Foundation’s donors, which enables local doctors to provide the care he (and countless other local patients) need. And he credits the clinical trials with prolonging his life—giving him the gift of extra time with his wife of 40 years, Hazel, and the two grandchildren who mean the world to him.

# TERRY BAUM

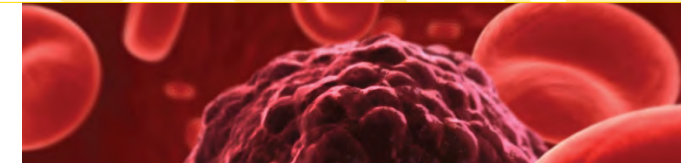
**“WE GIVE CANCER PATIENTS HOPE AND OPPORTUNITY.”**

## DID YOU KNOW

Patient assistance is key to our mission at the Foundation. In 2012, we provided transportation to clinical trials for 44 patients and fuel cards to 165 others facing financial hardship. And through our Trust in Hope program, we delivered Thanksgiving meals to 49 patients and their families and provided holiday gifts to 13 terminally ill patients and their children.

# LIZ PISANO

## “I KNOW GENETIC TESTING PLAYED A ROLE IN SAVING MY LIFE.”

Cancer has hit East Peorian Liz Pisano’s family hard. Her brother lost his battle with colon cancer at age 21. Her mother survived breast cancer. Then Liz was diagnosed with colon cancer in January 2007 and a brain tumor four months later. Genetic testing at Illinois CancerCare uncovered a specific and rare gene mutation—knowledge that enabled Liz and her physician to develop a treatment plan that ultimately saved her life.

Today, countless others at risk of developing “cancer family syndromes” can take advantage of the state-of-the-art genetics program at Illinois CancerCare, which helps patients fighting Hereditary Breast and Ovarian Cancer, Hereditary Nonpolyposis Colorectal Cancer and other genetic cancers. Genetic testing enables physicians to uncover red flags that may signal the onset of various cancers and identify possible gene mutations. With this knowledge, patients like Liz and their family members who carry certain genes can take preventive measures—such as mammograms, MRIs, colonoscopies and other screenings—as they take steps to save their own lives.

Illinois CancerCare’s Dr. James Knost and Nancy Donini are recent graduates of the Intensive Course in Cancer Risk Assessment, presented through the City of Hope Division of Clinical Cancer Genetics. In this program, participants from around the world join together to foster research and elimination of disparities in medical care related to genetic screening and testing. This certification means Illinois CancerCare is able to provide the most up-to-date genetic services right here in central Illinois.

Raised through Foundation-sponsored events in 2012: CUREageous, Morton BBQ Throwdown and Golfin’ in the Wild



The highlight of our third annual CUREageous—which included raffles, a silent auction and entertainment by the Gamma Phi Circus—was the recognition of five area “Rock Docs” for their outstanding contributions to medical research. The event raised more than \$90,000.

For the second year in a row, the Morton BBQ Throwdown attracted thousands of barbeque lovers. More than 30 professional teams competed in the event, which generated \$20,000 for the Foundation.

Also in 2012, our Young Leaders board organized our first Golfin’ in the Wild event at Wildlife Prairie Park, raising nearly \$14,000. Each hole on the par-3 course had a theme and challenged participants to use a single club to knock their golf balls through a wicket.
